# Routes to Impact

## Set up a Donor Advised Fund (DAF)

This tailored, private, giving vehicle is ideal for those who wish to pursue personal charitable interests, as well as those wishing to avoid the administrative burden and costs associated with starting their own Foundation.

Flexibility is key to this offering, including around the duration of investment and engagement, sharing of decision making with family, as well as choices in relation to privacy.



## Donate to a Fund

Supporting an existing fund is highly strategic and facilitates a collaborative and effective way to give.

Donations can be combined for maximum impact in supporting particular cohorts in society including Older People, Women, Young People and Children, as well as important issues such as the Environment and addressing Discrimination and Inequality
