Range of Legacy Options

Community Foundation Ireland offers a unique solution to legacy giving, guaranteeing the greatest possible societal impact for your gift, no matter the amount.

Your legacy giving should be as individual as you are. It should reflect your values and interests, the charities and causes dear to you, as well as your hopes for the future of your community. We have an expert team who can support you to explore a range of options, allowing you to give with confidence.

The following pages set our options and we are happy to discuss which is best for you.



Option 1: Foundation directed

We invest all legacies, unless otherwise directed, into our collaborative Community Foundation Ireland Endowment Fund, thus securing your gift, alongside that of your peers, in perpetuity.

Give to the Endowment Fund

By using your legacy gift to contribute to the Fund you bring strength by pooling resources with others to grow a fund from which returns are drawn down each year to respond to the most pressing issues of that time. For example, in recent years the impact of war, the cost-of-living crisis and Covid-19.







How it works

Effectively, these legacies are left in a trust to be directed by the Foundation's Board in response to society's greatest needs as they arise in future.

How it is used

Used strategically the Fund supports communities in crisis, not just in terms of immediate need but also in finding strategic solutions to secure a sustainable future.

An Endowment Fund is a powerful way for donors to create a lasting contribution, benefiting both the cause and the donor. It is an approach to Philanthropy that ensures your donation has a perpetual impact.

Option 2: Donor directed

Whether you aim to create a legacy for future generations, support causes in the near term, or give your family the chance to engage in philanthropy, you can choose the path that aligns with your values.

Create your own Endowment Fund

Create your own Endowment Fund, to be managed by the Board and Investment Committee of The Foundation.

Share your charitable wishes with our expert team and the Foundation will honour them to the best of our ability in the following decades.

Sub-funds can be created for family members, giving them the opportunity to explore their philanthropic interests with full autonomy over their charitable choices.





Term Fund

Create a Term Fund for your legacy gift, which will be invested over a shorter timeframe (e.g. 5-10 years).

Your original gift, and the investment return earned on it, will be granted over an agreed period of years, on a regular basis, as preagreed with you in line with your express charitable wishes.

Flow Through (i.e. Current) Fund

Create a Flow Through (i.e. Current) Fund for your legacy gift. A more short-medium term plan is created for your legacy gift and we can direct your giving towards the cause or causes closest to your heart.



Start the Conversation
